4. WAIVER OF LIABILITY AND ASSUMPTION OF RISK RELATING TO CORONAVIRUS/COVID-19

The novel coronavirus, SARS-CoV-2, and its resulting disease, COVID-19, have been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregating of groups of people.

Coast Kids Preschool, a ministry of North Coast Calvary Chapel, has put in place preventative measures to reduce the spread of COVID-19. However, Coast Kids Preschool cannot guarantee that my child(ren) or I will not become infected with COVID-19. Further, attending the Coast Kids Preschool could increase my risk and my child(ren)'s risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or contract COVID-19 by attending Coast Kids Preschool, a ministry of North Coast Calvary Chapel, and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or contracting COVID-19 at Coast Kids Preschool, a ministry of North Coast Calvary Chapel, may result from the actions, omissions, or negligence of myself and others, including, but not limited to, Coast Kids Preschool employees and program participants and their families.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at Coast Kids Preschool or participation in Coast Kids Preschool programming ("Claims"). On my behalf, and on behalf of my children, I hereby release, discharge, hold harmless, and covenant not to sue Coast Kids Preschool and North Coast Calvary Chapel, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of Coast Kids Preschool, a ministry of North Coast Calvary Chapel, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any Coast Kids Preschool program.
